BACKGROUND

BOA 2021-05 - 1821 Westminster Place

The property is zoned R-1-60.

The applicants desire to build an addition to the main dwelling. For the proposed addition, the applicants are seeking a 4'2" variance to the east side yard setback, leaving a 1'10" east side yard setback.
