Participants who wish to speak on items on the agenda will be placed on mute until the Chairman recognizes the caller to speak.

If the teleconference is disconnected at any time during the meeting, the meeting will be stopped and reconvened once the audio connection is restored. If communication is unable to be restored within 30 minutes, the presiding officer will recess the meeting to a future time to be stated on a revised posted agenda, which will be placed on the City website.
