TO BE READ INTO THE MINUTES: The City of Nichols Hills has received from Oklahoma Department of Environmental Quality, Permit No. WL000055150144 for the construction of approximately 160 L.F. of six (6) inch water lines and appurtenances to serve the City of Nichols Hills Replacement Raw Water Wells 2, 5, and 8 connecting water lines project, Oklahoma County, Oklahoma.

- e. TO BE READ INTO THE MINUTES: The City of Nichols Hills has received from Oklahoma Department of Environmental Quality, Permit No. WW000055150005 for the construction of three replacement raw water wells each drilled and completed to a depth of approximately 700-feet, including 100-feet of steel surface casing, estimated 200-gpm submersible pump, well house; and appurtenances to serve the City of Nichols Hills Replacement Raw Water Wells No.: 2, 5, and 8 Project, Oklahoma County, Oklahoma.
- f. TO BE READ INTO THE MINUTES: The City of Nichols Hills has received from Oklahoma Department of Environmental Quality, Permit No. WL000055150033 for construction of approximately 4,700 L.F. of six (6) inch replacement water lines; twenty (20) additional fire hydrants to be installed on existing City-wide distribution water lines to reduce fire hydrant spacing; and appurtenances to serve the City of Nichols Hills Water Line Replacement and additional Fire Hydrants in the Distribution System, Oklahoma County, Oklahoma.

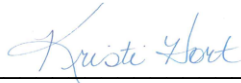
Discussion, consideration and possible approval of the following:

- a. A resolution of the City Council of the City of Nichols Hills & Nichols Hills Municipal Authority (also known as Nichols Hills Public Works Authority) approving an amended and restated trust indenture for the Oklahoma Municipal Retirement Fund; providing amendments to the Trust to authorize daily valuations and daily accounting for assets within the master defined contribution plans administered by Oklahoma Municipal Retirement Fund; providing for daily valuation of participant accounts in the defined contribution plans administered by Oklahoma Municipal Retirement Fund and providing procedures and rules for accounting of such assets; providing for effective date of amended and restated trust indenture and continuing existing trust as amended in full force and effect.
- b. Discussion, consideration and possible approval or disapproval of an ordinance adopting and enacting the "Nichols Hills City Code 2012-2014 Bi-Annual Cumulative Supplement" (The "Code Supplement"); providing for severability; repealing all conflicting ordinances or parts of ordinances; providing for publication by summary in accordance with State law; and declaring an emergency.
 - 1) Consider, discuss and approve or disapprove the emergency section of the foregoing ordinance.
- c. Discussion, consideration and possible approval or disapproval of a resolution directing the City Clerk, upon publication of the "Nichols Hills City Code 2012-2014 Bi-Annual Cumulative Supplement" (the "Code Supplement"), to notify the public of said Code Supplement; and further directing the City Clerk, after receipt of the publication of the Code Supplement, to file certified copies of this resolution and of said Code Supplement with certain designated governmental entities.
- d. Discussion, Consideration and Possible Action to ratify and approve Registrar, Transfer Agent and Paying Agent Agreement with BOKF, NA dba Bank of Oklahoma for \$4,200,000 General Obligation Bonds, Series 2015.
